

**City Council Meeting/Public Hearing
Minutes
September 14, 2021
5:15 PM
Council Chambers**

The Regular Meeting of the Crestview City Council was called to order at 5:15 P.M. Members present: Shannon Hayes, Doug Capps, Andrew Rencich, Cynthia Brown. Also present were the honorable Mayor JB Whitten, City Clerk Elizabeth Roy, City Manager Tim Bolduc, City Attorney Mr. Holloway, department heads and members of the press. Mr. Blocker was not in attendance.

1. Called to Order

This meeting was called to order by the Honorable Mayor Whitten at 5:15 p.m.

5. Public Hearing/Resolution Tentative Millage and Budget

5.1 Tentative Millage Resolution 2021-13

Mr. Bolduc, City Manager stated that the City has 65-80 days from the date of setting the proposed millage rate to hold a Public Hearing on its adoption and then asked the City Clerk to read Resolution 2021-13 by title.

Ms. Roy, City Clerk stated, "Resolution 2021-13 ready by title:

FOR AN EFFECTIVE DATE**

Mr. Bolduc, City Manager stated that the proposed millage rate for Truth in Millage (TRIM) was set at 6.9466 by the City Council in the July 26, 2021, Regular Council Meeting and has been certified by the County Property Appraiser as having a gross taxable value for operating purposes not exempt from taxation with Okaloosa County of \$1,418,144,240.

There was a brief discussion with a Citizen concerning a tax increase with the newly annexed Foxwood.

Mayor Whitten asked for action by Council.

A motion made by Mr. Rencich to adopt Resolution 2021-13 adopting the Tentative Millage Rate at 6.9466 for the fiscal year 2022. Seconded by Mr. Capps with 4 yeas from Mr. Rencich, Mr. Capps, Mr. Hayes, Ms. Brown with 0 nays, motion carried.

5.2 Tentative Budget Resolution 2021-14

Mr. Bolduc, City Manager asked the City Clerk to read Resolution 2021-14 by title.

Ms. Roy, City Clerk stated, "Resolution 2021-14 reads by title:

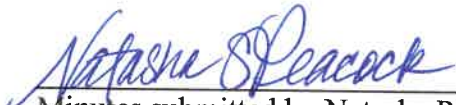

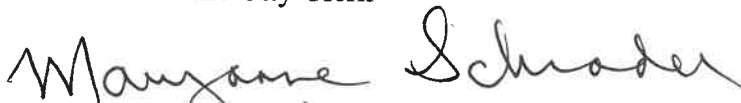
